**Timeline of Events:**

- 06.18.21\_ Council received inspection report for Stonewall Bar & Grill dated 05.14.21. Structure maximum safe life of 1-2 years
- 02.21.2021\_Resolution 21-348A approved Business License for 2022
  - Council only offered the sole liquor license to Stonewall Bar for one year opposed the previous five years
- 05.10.22\_ Council requested to invite Kylie Mills to June meeting for an updated inspection report and review of building condition
- 06.13.23\_ Council reviewed Stonewall Bar inspection report dated 05.24.2023 and discussed letters sent to bar to address the damaged awning.
- 09.12.2023\_ Council approved request to have monthly dance events and approved a 3.2 malt liquor license.
- 10.10.2023\_ Council received an update on 3.2% liquor license. City received feedback from state regarding liquor licensing and hosting an event with a catering permit. City attorney was contacted following the meeting.
- 11.11.2023\_ City Attorney letter to Council on how to handle liquor license for Stonewall Bar for new location and suggestion on hall rental with request for alcohol. Included email communication with lawyer.
- 11.14.2023\_ Kylie Mills attended Council meeting to present plans for purchase of new building at 106 Wall Street W. Kylie Mills was told to apply for a conditional use permit. Council received Liquor License Renewal request for D's Mart 3.2% and Stonewall Bar. Council received hall rental update with alcohol, renter will need to be served by a licensed liquor holder with a catering permit otherwise deposit will not be refunded. Tabled until other licensing issues were resolved.
